CHARITY COMMISSION.

In the Matter of the Charity of **SUSANNAH ELIZA COVEY**, founded by Will proved at Winchester on the 11th April 1885, for the benefit of the National and British Schools of the Parish of **NEW ALRESFORD**, in the County of **SOUTHAMPTON**; and

In the Matter of "The Charitable Trusts Acts, 1853 to 1891."

a majority of the Trustees of the above-mentioned Charity, all the other Trustees being privy to the application:

And it appearing that the endowment of the Charity consists of the sum of Stock mentioned in the Schedule hereto :

And after due notice of the intention to make this Order published according to the direction of the Board by being affixed to or near a principal outer door of the Parish Church of New Alresford, and of Perin's School, on the 5th December 1892, and by advertisement in the "Hampshire Chronicle" newspaper on the 10th December 1892 (being in each case more than one calendar month previously to the date hereof) :

And after due consideration of all objections made to the proposed Order and suggestions for the variation thereof :

Do hereby Order as follows, viz. :—

SCHEME.

Exhibition for
higher education.

The yearly income of the Charity shall be applied in the maintenance of an Exhibition or Exhibitions, tenable at Perin's School at New Alresford, or at any place of education higher than elementary, or of Technical, Professional or Industrial instruction approved by the Trustees, and to be awarded to deserving children, bonâ fide resident in New Alresford, who in every case have attended a Public Elementary School or Schools for not less than three years and have reached a standard higher than the standard for total exemption from school attendance fixed by the bye-laws in force for the time being in the School District in which such children are respectively resident.

Period.

Each Exhibition shall be awarded for such period, not being more than two years from the date of the award, as the Trustees think fit ; but such period may, whenever the Trustees think fit, be from time to time extended, provided that no Exhibition shall in any event be tenable for a period exceeding three years.

Conditions.

The Exhibitions shall be awarded and held under such regulations and conditions, and on the result of such examination as the Trustees think fit. Every Exhibition shall be given as the reward of merit, and shall, except as herein provided, be freely and openly competed for, and shall be tenable only for the purposes of education. Any Exhibition for which there shall be no candidate, qualified for the same as aforesaid, who on examination shall be adjudged worthy to take it shall for that turn not be awarded.

If the holder of an Exhibition shall, in the judgment of the Trustees be guilty of serious misconduct or idleness, or fail to maintain a reasonable standard of proficiency, or wilfully cease to pursue his or her education, the Trustees may deprive him or her of the Exhibition, and for this purpose may act on the report of the proper authorities of the school or place of education at which the Exhibition is held, or on such other evidence as the Trustees think sufficient, and for this purpose the decision of the Trustees shall be final in each case. Deprivation.

The Trustees shall, at their discretion, apply every sum awarded under the foregoing provision in or towards paying the tuition fees (if any) of the child, or otherwise for his or her maintenance or benefit, or they shall deposit the same in a Savings Bank, or otherwise accumulate the same for his or her benefit. Mode of application.
